


AGREED MINUTES

1. A delegation jointly representing the Aeronautical Authorities of Denmark, Norway and Sweden (hereinafter the “Scandinavian delegation”) and a delegation representing the Aeronautical Authority of Costa Rica met during ICAN2025 in Punta Cana on 13 November 2025 to negotiate bilateral Air Services Agreements between their respective countries.
2. A list of the two delegations is attached as Appendix I.
3. The negotiations were conducted in a friendly and cordial atmosphere, where the Parties desire to further develop friendly and cooperative relations between them based on equality and mutual benefit, and recognise the importance of the air transport sector and its contribution to the economic and social development of both Parties.
4. The delegations agreed upon and initialled Air Services Agreements and a Memorandum of Understanding concerning the co-operation between the Scandinavian countries regarding Scandinavian Airlines System (SAS), attached as Appendices II and III.
5. The Parties undertook to recommend to their respective governments to finalize their internal procedures for signature and entry into force of the Air Services Agreements as soon as possible.
6. Considering that the signing and entry into force of the initialled Air Services Agreements and the Memorandum of Understanding may require some time, the delegations agreed to give immediate practical effect to the initialled Air Services Agreements and Memorandum of Understanding, on an administrative and reciprocal basis, pending their signature and formal entry into force, to the extent possible under national law.

Done at Punta Cana, the Dominican Republic on 13 November 2025.
